ORDER:

In pursuance to the reference cited and in exercise of the powers conferred under Rule 58 of the Puducherry Co-operative Societies Rules, 1973, the Registrar of Co-operative Societies hereby permits the Puducherry Public Servants Cooperative Credit Society Ltd., No. P.52 to incur an expenditure of not exceeding **Rs.12,08,000/- (Rupees Twelve lakhs and eight thousand only)**, from the general funds of the society for the expenditure to be incurred towards Construction of Infra-structure at Ground Floor of the society, through Puducherry State Co-operative Housing Federation (HOUSEFED), Puducherry, at VVP Nagar, Thattanchavady, Puducherry for the purpose of Renting the Building to HOUSEFED for Jewel Loan Section. Further, it is requested to ensure strict economy in spending for this purpose.

2. The actual expenditure shall be charged in the accounting year **2025-2026** itself and proper account shall be maintained for above said purpose.
