ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 28.01.2025, under Section 6 of the Right to Information Act, 2005, (hereafter "the Act") to the respondent-society and sought for certain information. The respondent furnished reply to the appellant on 27.02.2025.

2. Not satisfied by the response of the respondent, the appellant filed this first appeal dated 03.03.2025 received in this office on 04.03.2025 seeking for information of his Form -1 dated 28.01.2025.

3. The response of the respondent society was called for, vide notice dated 05.03.2025. The respondent has furnished his response vide letter dated 12.03.2025 **(Copy Enclosed)**. On perusal, the following are observed:

- a] the respondent society has furnished the available information for sl.nos.1,3 and 4.
- b] In respect of Sl.No.2 of the appellants Form-1 dt. 28.01.2025, the appellants has sought for number of members constituencywise during the period from 20.11.2024 to 31.01.2025, but the respondent-society has furnished to total number of members. In this regard, the respondent-society is ordered to furnish number of members constituencywise during the period from 20.11.2024 to 31.01.2025 as sought for in the appellants Form-1 dated 28.01.2025 within a period of 15 days from the date of receipt of this order, free of cost.
- c] In respect of Sl.No.5 of the appellants Form-1 dt. 28.01.2025, the appellants has sought for additional share capital amount paid the members constituencywise, but the respondent-society has given reply that the information was already given to the appellant on 06.09.2024 & 21.11.2024. The said information is not valid. Therefore, the respondent-society is ordered to furnish the details additional share capital amount paid the members constituencywise as sought for in the appellants Form-1 dated 28.01.2025 within a period of 15 days from the date of receipt of this order, free of cost.

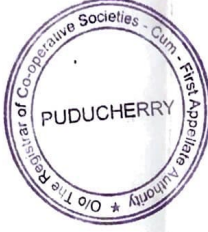
