ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 04.03.2025, under Section 6 of the Right to Information Act, 2005, (hereafter “the Act”) to the 1st respondent and sought for certain information. The 1st respondent transferred the application under Section 6(3) of the Act to the President-cum- Public Information Officer, Nedungadu Farmers Service Co-op Society Ltd., P.No.72 (2nd Respondent society) for furnishing information directly to the appellant on 11.03.2025. The 2nd Respondent society furnished reply to the appellant vide letter dated 10.04.2025.

2. Not satisfied with the response of the 2nd respondent society, the appellant filed this First Appeal dt 07.05.2025 on the ground that, the reply received is not satisfactory to the Chief Secretary, Government of Puducherry which was received by this office on 02.06.2025 from the Under Secretary (Co-operation) vide I.D. Note No.2239/CS(Co-op)/A3/2025, dated 31.05.2025.

3. The response of the respondents were called for, vide notice dated 05.06.2025. The respondents have furnished their response vide letters dated 12.06.2025 and 14.06.2025 respectively (**Copy Enclosed**).

4. On perusal, the following facts are observed:

- a) Since the information sought by the appellant are available only in the Nedungadu Farmers Service Co-op Society Ltd., P.No.72 (2nd Respondent society), the 1st respondent transferred the application dated 04.03.2025 under Section 6(3) of the Act 2nd Respondent for furnishing the required information directly to the appellant on 11.03.2025.

b) The 2nd respondent society has reiterated the information furnished earlier and furnished the available information for the appellant Form-1, dated 04.03.2025.

5. In view of the above submissions, it is found that, the plea of the appellant is redressed. As nothing survives in this appeal, this first appeal is dismissed.

6. If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
