ORDER:

In partial modification of the proceedings cited and in exercise of the powers conferred under sub-section(1) of Section 33 of the Puducherry Cooperative Societies Act, 1972, the undersigned is hereby appoint a three members committee consisting of the following members to manage the affairs of the Kariyamanickam Co-operative Milk Producers' Society Ltd., No.P.275, with immediate effect, **only for a period of 6 months from the date of assumptions of charges of the society.**

2. Thiru. P.Veerappan, M.No.623, **shall act as the President** of the said committee. The committee shall have powers to exercise all or any of the functions of the committee or any officer of the said society and to take all such action as may be required in the interest of the society, subject to my control and to such instructions as the undersigned may give from time to time under sub section (2) of the said section.

3. The three-member committee should invariably adhere the following instructions, without any deviation:

- i. The three-member committee should arrange to complete election to the committee of management within six months from the date of assumption of charges;
- ii. The three-member committees should not take any policy decision, which may affect the financial position of the society, without prior permission of the Registrar of Co-operative Societies;
- iii. The three-member committee should not engage or appoint any staff / remove or regularization of any staff, without prior permission of the Registrar of Co-operative Societies;
- iv. The three-member committee should not either re-instate the staff who is under suspension, or place any one under suspension, without prior permission of the Registrar of Co-operative Societies.

4. It may be noted that violation of the above said instructions, if any will be liable for legal action in accordance with law.
