**ORDER:**

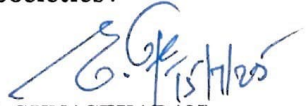
In pursuance of the reference cited and in exercise of the powers conferred under Rule 58 of the Puducherry Co-operative Societies Rules, 1973, the Registrar of Co-operative Societies hereby accords approval to the Puducherry Public Works Department Staff Cooperative Credit Society Ltd., No. P.252, to incur an expenditure not exceeding **Rs. 37,00,000/-** (Rupees Thirty-Seven Lakh only) from the General Funds of the Society.

This expenditure is sanctioned towards the procurement and distribution of **1850 Cracker Gift Boxes**, each valued at **Rs. 2,000** on the occasion of Diwali 2025 for the **members** of the Society and the **Pay Drawing Officers, Cashiers and Higher Officials** of the Public Works Department, for the financial year 2024-2025 subject to the following conditions:

- i. The purchase of Cracker Gift Boxes shall be made through a **Purchase Committee** to be constituted from among the Society members.
- ii. A valid **license for the storage of crackers** shall be obtained from the Revenue Department prior to procurement.
- iii. The actual expenditure shall be **accounted for in the financial year 2024-2025**.
- iv. **Proper records and documentation** of the procurement and distribution shall be maintained by the Society.
