management – Appointment of Administrator – Ordered.

ORDER

WHEREAS the term of office of the committee of management of the JIPMER Staff Co-operative Thrift and Credit Society, No. P. 231, which expired on 30.6.2015, was extended for three months from 1.7.2015 to 30.9.2015, vide reference cited, as the committee proposed to amend the bye-laws to reconstitute the constituencies and then conduct election to the committee;

AND WHEREAS, in the general body meeting held on 29.5.2015, amendment was proposed, inter alia, to bye-law No. 32(1)(b) of the bye-laws of the society without providing for reservation to the scheduled caste in the committee, contrary to the provisions of sub-section(3) of Section 32 of the Puducherry Co-operative Societies Act, 1972;

AND WHEREAS, when the infirmity in the said proposal was pointed out, the committee, vide letter dated 2.9.2015, sought extension of the term for a further period of three months to convene the general body meeting and for conducting election after reconstituting the constituencies;

AND WHEREAS, the said meeting was not chaired by the President of the society and it was indicated in the letter that the matter was with the approval of the President;

AND WHEREAS, in the meeting held on 7.4.2015 in my chamber, the committee members assured that they would place the special reports on the irregularities pointed out by the auditors for various years in the next general body meeting and send the compliance reports forthwith;

AND WHEREAS, even after expiry of four months of the last general body meeting, nothing was forthcoming from the society, as assured;

AND WHEREAS, it goes to show that the committee was not sincere in its assurance;

AND WHEREAS, in the light of above, the request of the committee in seeking extension of its term is considered neither desirable nor conducive to the interest of the members and depositors;

AND WHEREAS, in the above circumstances, I am satisfied that a new committee cannot be constituted before the expiry of the term of office of the existing committee and to manage the affairs of the society, till a new committee enters upon office, an Administrator is to be appointed, invoking sub-section (1) of Section 33 of the Puducherry Co-operative Societies Act, 1972;

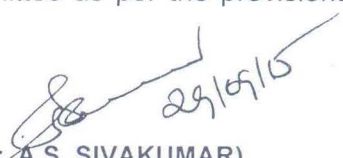
AND WHEREAS, the financing bank, namely, Pondicherry State Co-operative Bank was consulted in the matter of appointment of an Administrator to the said society and the said bank has no objection for appointment of an Administrator to the society;

AND WHEREAS, I am also satisfied that it is not reasonably practicable to publish a notice on the notice board of the society inviting objections on the proposal of appointment of Administrator, as required under the first proviso of sub-section (1) of Section 33 of the Act, as alternative arrangements are to be made expeditiously.

NOW, THEREFORE, in exercise of the powers conferred on me under sub-section (1) of Section 33 of the Puducherry Co-operative Societies Act, 1972, I hereby appoint Thiru G. Ganesan, Deputy Registrar of Co-operative Societies (Credit), as Administrator of the JIPMER Staff Co-operative Thrift and Credit Society, No. P. 231, in addition to his normal duties, with effect from 1.10.2015.

The Administrator shall exercise all the powers of the committee, subject to my control and to such instructions as may be given from time to time.

He shall take steps to constitute a new committee as per the provisions of the Act, Rules and Bye-laws of the society.
