The Puducherry Handlooms Weavers Welfare Fund Rules 1988 was brought in to force from 01/08/1989 as per the G.O 1st cited. An amendment was approved vide G.O 6th cited enhancing the quantum of Superannuation Pension and family pension to the handloom weavers in the Union Territory of Puducherry.

2) The quantum of superannuation Pension payable per mensum shall be based on age-wise classification as detailed in the table below, in case of eligible weaver member who has earned an average wage of not less than Rs.300/- mensum in each year of the three years preceeding the date of retirement :-

Provided that, the existing recipient of pension shall continue to draw Pension at the rate prescribed in column(3) corresponding to the Recipient's age group as at column(2) of the table above”.

3) The quantum of Family Pension payable Per mensum shall be based on age-wise classification as detailed in the table below, to the nominee or the legal heir, as the case may be of the deceased weaver member who has earned an average wage of not less than Rs.300/- mensum in each of the three year preceeding the month in which the death occurs.

Provided that, the existing recipient of family pension shall continue to draw Family Pension at the rate prescribed in column(3) corresponding to the Recipient's age group as at column(2) of the table above".

4) The Managing Director PONTEX is instructed to ascertain the age of the existing pensioners (Superannuation and Family Pension) before disbursement of the increased amount of pension. The increased pension shall be disbursed with effect from February 2016.
