CIRCULAR

Sub: Union territory of Puducherry - Registered cooperative societies – Purchase and sale of goods and services – Registration with GeM portal – Instructions - Issued.

Majority of the registered cooperative societies, which function in the Union territory of Puducherry, buy / sell goods and services. In respect of purchase of goods, they usually obtain three quotations and choose the least one. In this regard, it is informed that, the Government of India launched one-stop Government e-Marketplace (GeM) portal, hosted by Directorate General of Supplies and Disposals (DGS&D) where common user goods like computer, furniture, electrical/electronic item, stationery and services can be procured. GeM is dynamic, self-sustaining and user-friendly portal. *GeM doesn't charge even registration fees.* GeM is a completely paperless, cashless and system driven e-market place that enables procurement of common use goods and services with minimal human interface. GeM eliminates human interface in vendor registration, order placement and payment processing to a great extent and brings in transparency.

2) In view of the above, the management of all the cooperative societies, which function in the Union territory of Puducherry, and intend to buy and/ or sell goods and to provide services, are hereby instructed to immediately register their societies with GeM portal. Societies may utilize the guidance / assistance of Thiru P.Ranganathan, Managing Director (I/c), Pondicherry State Cooperative Union Ltd., regarding registration with the GeM portal.
