CIRCULAR

- Sub:** Union territory of Puducherry - Registered cooperative societies – Coronavirus (COVID-19) - Breaking the chain of transmission – “Aarogyasetu Application (APP)” – Downloading and effective use - Instructions to employees and members of the committee of management – Issued.
- Ref:** I.D.Note/Office Memorandum No.A.49011/12/2020/DPAR/CCD(2) dated 29.04.2020 of the Department of Personnel & Administrative Reforms (Personnel Wing), Government of Puducherry.

In order to break the chain of transmission of coronavirus (COVID-19) and as instructed by the Government of India, the following instructions are given to the employees, including daily-rated and out-sourced employees, and the members of committee of management of all registered cooperative societies, which function in the four regions of Union territory of Puducherry, for strict adherence:

- All the employees should immediately download the “Aarogyasetu Application” (APP), i.e., software program, on their mobile phones.
- Before proceeding to the society from home, employees must review their health status on the said APP and commute only when the app shows “safe” / “low risk” status. If the said APP shows “moderate” / “high risk” status, they shouldn't proceed to the society and should self-isolate themselves for 14 days or till the status becomes “safe” / “low risk”.
- It must be ensured that, on one should be allowed to enter the society premises without wearing a face mask.
- The practice of “social distancing”, i.e., a non-pharmaceutical infection prevention and control mechanism, must exist in the society premises.
- Members of the committee of management of societies, who intend to come to the society, must also download and effectively use the said APP.

2) This circular must be circulated among the members of the committee of management and the employees for strict compliance. The receipt of this circular is to be acknowledged and the action taken report shall be sent to the administrative branch officers within a week.
