CIRCULAR

Sub: Apex, Central and Major cooperative societies – **Asset monetization** – Identification of assets – **Submission of report** - Instructions - Issued.

It is informed that, the NITI Aayog of Government of India has recently formulated a novel scheme, viz., "Asset Monetization", which means monetization of unutilized and/or underutilized assets owned by Government and State-owned enterprises. In this regard, the first step would be identification of unutilized / underutilized assets for monetization. In respect of cooperative societies, the Secretary to Government (Planning), Govt. of Puducherry has directed to furnish the "Asset Monetization Pipeline", in the prescribed format (**Annexure-1**). As instructed, the Joint Registrar of Cooperative Societies shall act as "**Nodal Officer**" in respect of this department and cooperative societies.

2) In view of the above, the management of apex, central and major cooperative societies, as listed in the **Annexure-2**, are instructed to submit their asset monetization action plan to the undersigned, in duplicate, in the prescribed format, immediately.
