PROCEEDINGS OF THE REGISTRAR OF CO-OPERATIVE SOCIETIES, PUDUCHERRY

- Subject:** Co-operative Department – Consumers – The Pondicherry Carpenters Industrial Co-operative Society Ltd., No.P.307 – Committee of Management of the society not functioning properly – Supersession – Orders – Issued.
- Read:** 1. Notice No. 5/8/1/15/RCS/Cons/WS/2005/100 dated 12-08-2014 issued under section 83(1) of the Puducherry Co-operative Societies Act, 1972

ORDER:-

WHEREAS, a notice was issued vide reference 1st cited under Sub section (1) of section 83 of the Puducherry Co-operative Societies Act, 1972 to the members of the committee of management of the Pondicherry Carpenters Industrial Co-operative Society Ltd., No.P.307 (herein after the society) giving an opportunity to the said committee to state their explanation as to why the committee should not be superseded in view of the following irregularities noticed in the working of the said society.

i) There exists no co-operation among the Board of Directors mainly there is much rift among the President and Vice- President.

ii) No Board meeting was held by the society after 19-05-2013, even though it is specified under bye-laws of the society, that the committee shall meet as often as may be necessary and at least once in three months to conduct the Business of the society

iii) The President of the society has claimed wages for the administrative work in the society, flouting the bye-law provision envisaged under Bye-law no.36 of the society. The committee of management of the society has no control over the employees in the event of disharmony relationship among the committee members.

iv) The Employees of the society were not paid salaries for several months. Even the Telephone bills and Electrical bills were unpaid and no business transaction is carried out by the society.

v) The functioning of the society is totally crippled in view of the irregular management of the society and the committee has failed to fulfil the objects of the society and to render services to the members.

2. AND WHEREAS, the said Committee of Management of the society was given opportunity to make a representation within 7 days from the date of receipt of this notice.

3. AND WHEREAS, only 5 members (Including Vice President) of the committee of the management of the society have furnished their explanation vide their letter 2nd cited;

4. **AND WHEREAS**, three members (including President) except the Registrar of Co-op. Societies nominee in the committee of the management of the society have not furnished their explanation;

5. **AND WHEREAS**, the committee members of the society in their reply have admitted their mismanagement in the society;

6. **AND WHEREAS**, in view of the above, I am of the opinion that the committee of management of the society is to be superseded and a Special Officer is to be appointed to manage the affairs of the society till a new committee is constituted by election.

7. **AND WHEREAS**, the financing Bank viz. The Pondicherry State Co-operative Bank Ltd. was also consulted on the matter of supersession and the said bank has "No objection" to the proposed action.

8. **NOW THEREFORE**, in exercise of the powers conferred on me under sub-section (1)(a) of section 83 of the Puducherry Co-operative Societies Act, 1972, I dissolve the committee of management of the Pondicherry Carpenters Industrial Co-operative Society Ltd., No.P.307 with immediate effect and appoint Thiru. C. Saravanane, Senior Inspector (Consumers Section), Co-operative Department, as the Special Officer for a period of six months from the date of assumption of office.

The Special Officer shall subject to my control and to such directions as I may from time to time, give, have the power to exercise all or any of the functions of the committee or of an officer of the society and to take such action as may be required in the interest of the society. He shall constitute a new committee by election in accordance with the provisions of the Act, the Rules and bye laws of the society before the expiry of his tenure as Special Officer of the Society.
