ANNEXURE

- (i) **PAY:-** During the period of deputation, the incumbents, shall continue to draw their pay and grade pay admissible to them from time to time in their parent Department plus deputation allowance, if any at the rate of 5% of basic pay subject to a maximum of Rs. 2000/- per month in accordance with and subject to the terms and conditions as communicated by the Department of Personnel and Training, Ministry of Personnel Public Grievances and Pensions, Government of India in O.M. No.6/8/2009-Estt.(Pay II), dated 17.06.2010.
- (ii) **DEARNESS ALLOWANCE:-** They will be entitled to dearness allowance at the rates prevailing in the parent department.
- (iii) They will also be entitled to the following allowances as admissible to the employees of the Government of Puducherry and the liability in this regard will be borne by the borrowing Department :-
- a) HRA / Transport Allowance.
 - b) Joining time and Joining Time Pay.
 - c) Travelling Allowances and Transfer T.A.
 - d) Children Education Allowance / Reimbursement of Tuition fees.
 - e) Leave Travel Concession.
- (iv) **MEDICAL FACILITIES:-** The medical facilities will be regulated in accordance with the rules of the borrowing organization.
- (v) **PROVIDENT FUND BENEFITS:-** During the period of deputation, they will continue to subscribe to the Provident Fund of their parent Department to which they are subscribing when they are placed on deputation in accordance with the rules of such funds.
- (vi) **INSURANCE SCHEME:-** They will continue to be governed by the Central Government Employees Insurance Scheme 1977 or the Union Territory Employees Group Insurance Scheme, 1984 as the case may be.
- (vii) **LEAVE AND PENSION:-** They will be regulated by the Leave and Pension Rules of the parent Department.
- (viii) **LEAVE SALARY / PENSION CONTRIBUTION:-** The leave salary contribution (except for the period of leave availed of on foreign service) and pension contribution / CPF (Employer's share) contribution are required to be paid by the borrowing organization.
