1. The payment for work done will be based on the rate quoted by the Tenderer.
2. The specifications mentioned above are tentative. Hence rates (inclusive of materials, Labour, fixing charges and all taxes etc.) should be quoted **Per unit for Ten days + Ten days (10 days + 10 days)** and also cost of each item in amount column invariably.
3. Payments will be made on successful completion of the events on production of original bill along with contingent bill form;
4. Standard/good quality materials only to be used and the quality of materials/items fixed in the venue are measurable.
 - a) If any additional item required during the execution of work apart from the list shall also be done with concurrence of the Puducherry State Co-operative Handicrafts & Handloom Federation Ltd., and accordingly payment will be made on recommendation of the Tender Committee.
 - b) If any item not required in the list during execution, that should not be utilized/operated and payment will be deducted accordingly.
5. The Tenderer should have the knowledge on venues like Gandhi Thidal, Beach Road, in Puducherry and other sites before quoting the rate.
6. The work should be completed and ready for trail run/rehearsal on one day prior to the Festival / event with all fixtures and there will be site inspection.
7. The Tenderer or his authorized representative should be available in the site from the commencement of the work till completion or programme.
8. The Tenderer who proposes any alteration of the conditions laid down or which proposes any other conditions of any descriptions whatsoever will not be accepted. However, the tender committee reserves right to take a decision.
9. The tender committee reserves the rights to reject any or all the tenders without assigning any reasons thereof.
10. Item rate quoted by contractor deemed to be inclusive of rental, transportation, loading unloading dismantling and clear all materials from the site inclusive of all Taxes.

11. The work should be started immediately after the receipt of the work order and completed in all respects within the stipulated time. Failure to complete within the said time will attract appropriate action, as decided by the tender committee.
12. The Tenderer is responsible for all the required safety measures including placing the required number of fire extinguishers/water provisions at the Gandhi Shilp Bazaar 2021 and Craft Bazaar 2022.
13. Payment will be made only after deducting all applicable taxes like TDS (Income Tax as applicable), Service tax and GST etc.,
14. Any dispute arising out between the Tenderer and the organizing committee, the Registrar of Co-operative Societies, Puducherry is the deciding authority.
15. The tender is non-transferable.
16. Tender offer from (BOQ) – Basic price, other taxes etc., for each item shall be entered by the tenderer in the prescribed column of Tender Schedule.
17. No column in the BOQ shall be left blank
18. The rate quoted should be only as per the unit printed in the Schedule.
19. The rate should be quoted both **in figure and words**. The rate should include all taxes applicable.
20. The successful tenderers themselves will have to obtain permits, license etc. that may be required in fulfilling the contract.
21. If the Government introduces any fresh taxes or increase the present rates of taxes, no change in the rates can be claimed.
22. The tender shall be submitted only if the Tenderer is agreeable to all the terms and conditions of the Tender, which includes the description and specifications of the items mentioned therein.
23. Irrespective of the terms and conditions that may have been specified by the tenderer, only the terms and conditions specified in this tender by the department shall be binding on the tenderer and the Tendering authority.

28. The tenderers are responsible to furnish all the required particulars along with the tender. No. correspondence will be made on this account from this office/department.
29. Tenderers submitted tender form other than the prescribed will be rejected.
30. The tenders/offers that received do not conform with the terms and conditions of the PSCH & HF Ltd., P-760 Puducherry will be summarily rejected.
31. Agreement:

The successful tenderer shall be required to execute an agreement stipulating all the conditions mentioned herein immediately on the date of communication of the approval of rate after remitting the required amount of performance guarantee returned.
