ORDER

WHEREAS the extended term of office of the committee of management of the Puducherry Public Works Department Staff Co-operative Society, No. P. 252 will expire on 30.9.2015;

AND WHEREAS the President of the society was requested to take steps to conduct election in accordance with the existing bye-laws before expiry of the extended term of office of the committee so as to enable the new committee to enter upon office on and from 1.10.2015, vide letter cited in ref.(2);

AND WHEREAS the President of the society, vide letter cited, stated that, election to elect a new committee of management as per the existing bye-laws could not be conducted, as the Government of Puducherry had redesignated 10 posts into MTS(PW) and consequently some of the posts mentioned in bye-law No.32(1) of the bye-laws of the society no longer exist. In such circumstances, extension of term of the committee is sought to amend the bye-laws and to conduct election thereafter;

AND WHEREAS in view of the above, I am satisfied that the term of the existing committee is to be extended,

NOW, THEREFORE, in exercise of the powers conferred on me under clause (b) of sub-section (5) of Section 32 of Puducherry Co-operative Societies Act, 1972, read with sub-rule (2) of Rule 41 of the Puducherry Co-operative Societies Rules, 1973, I direct the term of office of the committee of management of the Puducherry Public Works Department Staff Co-operative Society, No. P. 252, be extended for a period of one month, i.e., from 1st October 2015 to 31st October 2015.

The committee shall take all steps to conduct election within the extended term, so that a new committee can enter upon office on and from 1st November 2015. No further extension of term of the committee shall be permitted under any circumstances.
