ORDER

WHEREAS the extended term of office of the committee of management of the
Puducherry Public Works Department Staff Co-operative Society, No. P. 252 will expire
on 31.10.2015;

AND WHEREAS the committee of management of the society convened general
body meeting to amend the bye-law relating to constitution of the committee and
submitted proposed amendment, vide letter cited in ref(2), for registration and the
proposal is under scrutiny;

AND WHEREAS the President of the society, vide letter cited in ref(3), stated
that, inter alia, the proposal to amend the bye-laws of the society relating to the
constitution of the committee is under consideration of this office and hence election
could not be held to install a new committee before the expiry of the extended term of
the present committee;

AND WHEREAS in view of the above, I am satisfied that the term of the existing
committee is to be extended.

NOW, THEREFORE, in exercise of the powers conferred on me under clause (b) of sub-section (5) of Section 32 of Puducherry Co-operative Societies Act, 1972, read with sub-rule (2) of Rule 41 of the Puducherry Co-operative Societies Rules, 1973, I direct the term of office of the committee of management of the Puducherry Public Works Department Staff Co-operative Society, No. P. 252, be extended for a period of two months, i.e., from 1st November 2015 to 31st December 2015.

The committee shall take all steps to conduct election within the extended term, so that a new committee can enter upon office on and from 1st January 2016.
