ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 22.11.2021, under Section 6 of the Right to Information Act, 2005, (hereafter “the Act”) to the respondent-society and sought for certain information from the respondent. The respondent furnished the information to the appellant on 20.12.2021.

2. Aggrieved by the respondent's response, the appellant filed this first appeal dated 04.01.2022, on the ground that the reply of the respondent –society furnished information for Sl.No.3,4,5,8,9 only and out of which except for the information furnished for Sl. No.5, the rest of the information are not found satisfactory.

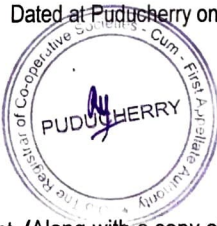
3. The response of the respondent was called for, vide notice dated 19th January 2022. The respondent-society furnished their response vide letter dated 04.02.2022 (**Copy Enclosed**). On perusal, it is observed that the appellant made an application to the Deputy Registrar-cum- Public information Officer, Cooperative Department, Karaikal, on 22.11.2021, seeking information for Sl.Nos. 1 to 14. Since, the information in respect of the Sl.No. 10 to 14 is held by the other authority Viz., the Administrator, Karai-Kovilpathu PACCS, Karaikal, the said part only was transferred to them on 26.11.2021 by the D.R, Karaikal, for furnishing the information. The respondent furnished a reply on 20.12.2021 in respect of the Sl.Nos 3,4,5,8 and 9. The appellant preferred this appeal stating that the information furnished by the respondent is not satisfactory in respect of Sl.Nos.3,4,8 and 9. Now, it is found that the respondent-society furnished a revised response to the undersigned, which is forwarded herewith. Therefore, the plea of the appellant is found to be redressed and nothing remains unanswered.

4. In view of the above, as nothing survives in this appeal, this first appeal is dismissed.

5. If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
