ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 11.03.2024, under Section 6 of the Right to Information Act, 2005, (hereafter "the Act") to the respondent and sought for certain information. The 1st respondent furnished the information for Sl.nos.1 to 4 and 6 of the application vide letter dated 05.04.2024. Further the 1st respondent transferred the application under Section 6(3) of the Act to the President-cum-PIO, Keezhagraharam Primary Agricultural Co-operative Credit Society Ltd., No.P.89 (2nd Respondent) on 21.03.2024 for directly furnishing the information for Sl.nos.5 to the appellant. The 2nd respondent-society furnished a reply to the appellant on 09.04.2024.

2. Aggrieved by the response of the respondents, the appellant filed this first appeal dated 06.05.2024 on the ground that, the reply received was not satisfactory.

3. The response of the respondents were called for, vide notice dated 06.05.2024. The 1st respondent and 2nd respondent-society have furnished their response vide letters dated 21.05.2024 and 17.05.2024 respectively (**Copies Enclosed**). On perusal, it is observed that the 1st respondent reiterated their reply already furnished to the appellant on 05.04.2024 in respect Sl.nos.1 to 4 and 6. The 2nd respondent also reiterated their reply already furnished to the appellant on 09.04.2024 in respect of Sl.No.5. At the outset, it is found that, both the respondents furnished the available information with them. It is also found that, the appeal is preferred without any sustainable grounds. Since the requisite information were furnished by the respondents, nothing survives in this appeal.
