ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 27.04.2026, under Section 6 of the Right to Information Act, 2005, (hereafter "the Act") to the respondent-society and sought for information pertaining to the recruitment & regularization of employees in the Pondicherry Co-op. Milk Producers Union Ltd., (hereafter "the respondent-society") The respondent furnished reply to the appellant vide letter dated 22.05.2026.

2. Not satisfied with the response of the respondent-society for his Form-I dated 27.04.2026, the appellant filed this first appeal dated 26.05.2026 on the ground that, the stating that the reply furnished by the respondent-society is unsatisfactory.

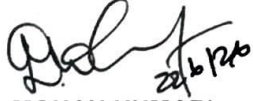
3. The parties are called up for a personal hearing on 17.06.2026 vide Notice dated 04.06.2026. Both the parties are present. During the hearing, the appellant submitted his appeal. The Public Information Officer of the respondent-society informed that, they have provided the factual information to the appellant for Sl.No.1 of his application dated 27.04.2026. On perusal of the Appeal, the First Appellate Authority ordered the respondent-society to furnish the available information for Sl.Nos. 2 & 3 of the appellant's Form-1, dated 27.04.2026 by providing the list of employees along with their name, designation and mode of recruitment to the appellant within 7 days to the appellant from the date of receipt of this Order, at free of cost.

4. With the above directions, this appeal is disposed of.

5. If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
