ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 09.05.2024, under Section 6 of the Right to Information Act, 2005, (hereafter “the Act”) to the respondent and sought for certain information. The respondent furnished reply to the appellant on 04.06.2024.

2. Aggrieved by the response of the respondent for Sl. Nos.3 & 5 of his RTI application, the appellant filed this first appeal dated 11.06.2024 on the ground that, the reply received was not satisfactory.

3. The response of the respondent was called for, vide notice dated 14.06.2024. The respondent has furnished his response vide letter dated 7.8.2024. It is stated therein that, ‘the appellant/applicant’s request in Form-I dated 07.08.2024 seeking the action taken on her petition dated 25.04.2024 in connection with the Kalapet PACCS, was forwarded on 17.05.2024 to the Credit Section with a request to furnish the available information. The reply received from the said section was sent to the applicant on 04.06.2024.’ Further after this appeal the credit section of this department has furnished the updated information in respect of the information sought at sl. No.1 of the Form-1 of the appellant **(Copy Enclosed)**.

4. On perusal, it is observed that, the Respondent has furnished the available information to the Appellant in respect of information sought at Sl.Nos.1,2,3,4 & 5. The Appellant pleaded in this appeal that ‘my query items Sl.Nos.3 & 5 are not supplied by the Public Information Officer’ is not valid, since in respect of the information sought at Sl.No.3, it is informed that, the inquiry report is yet to be received and for Sl.No.5, it is informed that the said information is not available.

5. In view of the above submissions, it is found that, the plea of the appellant is redressed. As nothing survives in this appeal, this first appeal is dismissed

6. If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
