ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 25.04.2026, under Section 6 of the Right to Information Act, 2005, (hereafter "the Act") to the respondent-society and sought for information pertaining to the Board of Management and loans issued by the Varichikudi Primary Agricultural Co-op. Credit Society Ltd., (hereafter "the respondent-society") The respondent-society furnished reply to the appellant vide letter dated 22.05.2026.

2. Not satisfied with the response of the respondent-society for his Form-I dated 25.04.2026, the appellant filed this first appeal dated 27.05.2026 (received in this office on 29.05.2026) stating that the reply furnished by the respondent-society is unsatisfactory.

3. The parties are called up for a personal hearing on 17.06.2026⁹ vide Notice dated 04.06.2026. Both the parties are present. During the hearing, the appellant submitted his appeal. The appellant expressed his aggression over the receipt of incomplete information for Sl.Nos.6 & 7 of his Form-1, dated 25.04.2026 calling for information pertaining to Jewel loans issued by the respondent-society. On perusal of the Appeal, the First Appellate Authority ordered the respondent-society to furnish the available information in full form for Sl.Nos. 6 & 7 of the appellant's Form-1, dated 25.04.2026 by providing the Jewel loans list with Loan No., Name and Loan amount within 7 days to the appellant from the date of receipt of this order, at free of cost.

5. If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
