ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 07.05.2023, under Section 6 of the Right to Information Act, 2005, (**hereafter “the Act”**) to the 1st Respondent through on line application and the said application was transferred to the 2nd respondent on 14.06.2023, since the information sought by the appellant pertains to the 2nd respondent society. But, the said 2nd respondent society did not furnish the information sought by the appellant.

2. Aggrieved by the non-response of the respondent- society, the appellant filed this first appeal dated 07.06.2023 through online which was received by Legal cell on 28.06.2023 from the Nodal Officer/ Deputy Registrar (Audit).

3. The response of the 2nd respondent society was called for, vide notice dated 28.06.2023. Till date the respondent society did not furnish their response.

4. On perusal, the followings are found : (i) the appellant has sought the copy of the order of recruitment rules framed for the post of principal/Lecturer as approved by the Registrar of Co-operative Societies vide order No.5/11/1/RCS/PLG/A/2003/383 dated 17.11.2004. (ii) the PIO of the respondent society has to furnish the available information to the appellant within 30 days from the date of receipt of the said application. (iii) The appellant aggrieved by the non-receipt of the information within 30 days, filed this appeal on 07.06.2023 through online which was received by Legal cell on 28.06.2023 from the Nodal Officer/Deputy Registrar (Audit). (iv) In this regard, the response of the respondent society was called for by this Authority (v) But, till date no response was received from the respondent society. It is found that the PIO of the respondent society neither furnished any information to the appellant for his application dated 07.05.2023 nor submitted their response called for by this Authority, which denotes that the respondent society did not discharge their duty in letter and spirit of the Act. It is much disgust to note that an apex body in respect of the propaganda of cooperative principles is not adhering the timeline for furnishing of information and response to this Authority. The said act of the respondent society attracts penalisation under the Act. In view of the above, the respondent society is ordered to furnish the available information to the appellant, within 15 days from the date of receipt of this order, as sought for in his application dated 07.05.2023, at free of cost.

5. Hence, ***the respondent is directed to meticulously adhere the provisions of the said Act, in letter and spirit, and henceforth dispose of the applications under the said Act within the stipulated time limit; failing which the respondent will be subjected to legal consequences as per the penal provisions of the said Act, including fine at the appropriate rate.***

6. With the above directions, this appeal is disposed of.

7. If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
