ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 16-06-2021, under Section 6 of the Right to Information Act, 2005,(hereafter “the Act”) to the respondent-society and sought for certain information from the respondent-society. The respondent – society furnished the information to the appellant on 14-07-2021.

2. Aggrieved by the respondent's response, the appellant filed this first appeal dated 04-08-2021, on the ground that the information furnished to him is not satisfactory.

3. The response of the respondent was called for, vide notice dated 09.08.2021. The respondent furnished his response, vide letter dated 23.08.2021 (**Copy enclosed**) wherein its earlier stand is reiterated.

4. On perusal, it is found that, the respondent-society furnished the available information sought at Sl.No. 7, 8 and 9. Whereas, the respondent-society found furnished the information sought at Sl.No. 1 to 6, but did not furnished the copies of it. It is also found that the appellant preferred this appeal without any specific grounds to substantiate his plea, except with an evasive statement that “he is not satisfied with the information furnished to him” on 14.07.2021. The appellant did not listed the reasons in his appeal why the information furnished to him is not satisfactory. However, it is viewed that the plea made by the respondent-society that the non- furnishing of the copies of information for Sl.No. 1 to 6, under Sec.8(1)(g) of the Act, does not hold good in the eyes of law.

5. Therefore, the respondent-society is directed to provide the copies of the information sought for, at **Sl.no.1 to 6** of his application dated 16.06.2021, to the appellant , within fifteen(15) days from the date of receipt of this order, at free of cost.

6. With the above directions, this appeal is disposed of.

7. If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
