ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 02-06-2021, under Section 6 of the Right to Information Act, 2005,(hereafter “the Act”) to the respondent and sought for certain information from the respondent. The respondent furnished the information to the appellant on 07-07-2021.

2. Aggrieved by the respondent's response in respect of the information sought at Sl.No. 2 to 8 and 10, the appellant filed this first appeal dated 06-08-2021 (received on 10.08.2021), on the ground that the information furnished to him is not satisfactory.

3. The response of the respondent was called for, vide notice dated 13.08.2021. The respondent furnished his response, vide letter dated 23.08.2021 (Copy enclosed The respondent reiterated their earlier stand furnished on 07.07.2021 and added that the information available in the inquiry report are furnished to the appellant.

4. On perusal, it is ascertained that the appellant preferred this appeal stating that he is aggrieved by the response for Sl.No. 2 to 8 and 10 only. From the respondent's response it is found that , the available information found in the inquiry report were furnished, with copies, for all the information sought by the appellant (Sl.No. 1 to 10). The appellant preferred this appeal without any specific grounds to substantiate his plea, except with an evasive statement that “he is not satisfied with the information furnished to him” on 07.07.2021. The appellant did not list the reasons in his appeal, why the information furnished to him is not satisfactory. As such it is found that the appellant did not substantiate his appeal, in the eyes of law. On the other hand, it is found the available information were furnished by the respondent on 07.07.2021 itself. Thus , it is held that nothing is left unaddressed by the respondent for the appellant application dated 02.06.2021.

6. In view of the above , as nothing survives in this appeal, this first appeal is dismissed for lack of merits.

7. If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
