ORDER

(Issued under Section 19 of the Right to Information Act,2005)

The appellant submitted an application dated 26.06.2023, under Section 6 of the Right to Information Act, 2005, (**hereafter “the Act”**) to the 1st respondent and sought for certain information. The 1st respondent transferred the application under Section 6(3) of the Act to the President-cum-PIO, Rajaji Weavers Co-operative Society Ltd., P.No.2 (2nd Respondent) on 03.07.2023 for directly furnishing the information to the appellant. The 2nd respondent society furnished a reply to the appellant on 25.07.2023.

2. Aggrieved by the response of the respondent- society, the appellant filed this first appeal dated 24.08.2023 stating that, the information sought for the point nos.3,5,6,7,9,10 & 14 were not furnished by the respondent- society.

3. The response of the respondents was called for, vide notice dated 30.08.2023. The 1st Respondent vide letter dated 04.09.2023 has stated that, she has transferred the application under Section 6(3) of the Act to the 2nd Respondent on 03.07.2023 for directly furnishing the information to the appellant. The 2nd respondent society furnished their response vide letter dated 08.09.2023 stating that, the information sought by the appellant are furnished.

4. On perusal, it is observed that the respondent-society has reiterated their reply made earlier and also furnished the additional available information for the point nos.3,5,6,7,9,10 & 14 which was sought by the appellant (**Copy Enclosed**). Thus, the plea of the appellant is found to be met out.

5. In view of the above, as nothing survives in this appeal, this first appeal is dismissed.

6. If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
