**ORDER**

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 23.07.2024, under Section 6 of the Right to Information Act, 2005, (hereafter “the Act”) to the respondent and sought for certain information. The Respondent furnished reply to the appellant vide letter dated 22.08.2024.

2. Aggrieved by the response of the respondent society for Sl.Nos.2 & 3 of his Form-1, the appellant filed this first appeal dated 16.09.2024 on the ground that, the reply received was not satisfactory.

3. The response of the respondent was called for, vide notice dated 27.09.2024. The respondent has furnished his response vide letter dated 03.10.2024. On perusal, it is found that, the reply furnished by the respondent is not proper. Hence, the undersigned called the parties for a personal hearing vide notice dated 22.10.2024 to appear before this authority on 08.11.2024, at 4.30 P.M.

4. The personal hearing was held on 08.11.2024 at 4.30 P.M. The appellant was called absent; the respondent was present. The appeal was heard by the undersigned in respect of the information sought by the appellant in Sl.Nos.2 & 3 and ordered the respondent to furnish a revised response for Sl.Nos.2 & 3 in the Form No.1 dated 23.07.2024 of the appellant.

5. Subsequently, a revised response was received from the respondent vide letter dated 11.11.2024 (Copy Enclosed). On observation, it is found that, the plea of the appellant is redressed. As nothing survives in this appeal, this first appeal is dismissed.

6. If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
