ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 14-09-2021, under Section 6 of the Right to Information Act, 2005,(hereafter “the Act”) to the respondent-society and sought for certain information from the respondent-society. The respondent – society furnished the information to the appellant on 04.10.2021.

2. Aggrieved by the respondent's response, the appellant filed this first appeal dated 16.10.2021 (**received on 18.10.2021**), on the ground that the information furnished is not satisfactory.

3. The response of the respondent was called for. In the meantime, a personal hearing was held on 11.11.2021, in respect of the F.A 16/2021. Since, the appellant in both the appeals (F.A 16 & 17/2021) are found to be the same, this appeal also was taken up during the said hearing. In the said hearing the respondent-society was represented by its Administrator and the appellant was called absent. The appellant vide his letter dated 08.11.2021 (**received on 11.11.2021**) stated that he could not appear for the personal hearing for the said appeal due to medical disabilities.

4. On perusal of the available records and in view of the submissions made by the Administrator during the hearing, the respondent-society is directed to provide the information sought for by the appellant, within fifteen(15) days from the date of receipt of this order, at free of cost.

5. With the above direction, this appeal is disposed of.

6. If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
