ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 27.08.2024, under Section 6 of the Right to Information Act, 2005, (**hereafter “the Act”**) to the respondent-society and sought for certain information. No response is received from the respondent-society within the time limit.

2. Aggrieved by the non response of the respondent- society, the appellant filed this first appeal on 08.07.2024, on the ground that the no response is received within the time limit.

3. The response of the respondent was called for, vide notice dated 09.10.2024. The respondent society furnished their response vide letter dated 06.11.2024. (**Copy Enclosed**). On perusal, it is observed that the respondent-society has now furnished the available information which was sought by the appellant. Thus, the plea of the appellant is found to be met out.

4. It is found that the respondent has failed to furnish his reply within the stipulated time limit of 30 days and has furnished information after the appellant came for First Appeal. If the respondent furnished his reply to the appellant within the stipulated time limit of 30 days, this first appeal wouldn't be preferred by the appellant.

5. Hence, ***the respondent is directed to meticulously adhere the provisions of the said Act, in letter and spirit, and henceforth dispose of the applications under the said Act within the stipulated time limit of 30 days; failing which the respondent will be subjected to legal consequences as per the penal provisions of the said Act.***

6. With the above directions, **this** appeal is disposed of.

7. If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
