ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an online application dated 27.06.2025, under Section 6 of the Right to Information Act, 2005, (hereafter “the Act”) to the 1st respondent and sought for certain information pertaining to the Pondicherry Co-operative Building Centre Ltd., No.P.554 (2nd respondent society). Since the information pertains to and available only in the society, the 1st respondent transferred the application of the appellant under Section 6(3) of the Act to the President-cum-Public Information Officer, 2nd respondent-society for furnishing information directly to appellant on 02.07.2025. The 2nd respondent-society furnished reply to the appellant vide letter dated 24.07.2025.

2. Not satisfied with the information received from the 2nd respondent society, the appellant filed this first appeal dated 08.08.2025 on the ground that, the reply given for his Form-1 dated 27.06.2025 is false, misleading, incomplete and evasive.

3. The response of the respondents were called for, vide notice dated 14.08.2025. The respondents have furnished their response vide letters dated 20.08.2025 and 23.08.2025 respectively (**Copy Enclosed**).

4. On perusal, the following facts are observed:

- a) Since the information sought by the appellant are available only in the 2nd Respondent-society, the 1st respondent transferred the application dated 27.06.2025 under Section 6(3) of the Act to the 2nd Respondent society for furnishing the required information directly to the appellant on 02.07.2025.

- a) The 2nd respondent society has furnished reply as "the information sought by the appellant has already been furnished". On observation, it is found that, the 2nd respondent society has already furnished the available information for the Form-1 dated 27.06.2025 of the appellant and reiterated the same in their response dated 23.08.2025. The information provided and reiterated by the respondent society is found to be adequate and appropriate. Thus, it is observed that nothing survives in this appeal.

5. In view of the reasons stated above, the appeal lacks merits, and hence, dismissed

6. If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
