ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 15.07.2025, under Section 6 of the Right to Information Act, 2005, (hereafter “the Act”) to the 1st respondent and sought for certain information pertaining to the Pondicherry Co-operative Building Centre Ltd., No.P.554 (2ndrespondent society). The 1st respondent furnished information for Sl. Nos.3 & 4 of his Form-1 dated 15.07.2025 and transferred the application of the appellant under Section 6(3) of the Act to the President-cum-Public Information Officer, 2ndrespondent-society for furnishing information for Sl.Nos.1,2,4,5,6,7 & 8 directly to appellant on 21.07.2025, since the information was available only in the society. The 2ndrespondent-society furnished reply to the appellant vide letter dated 04.08.2025.

2. Not satisfied with the information received from the 2nd respondent society, the appellant filed this first appeal dated 18.08.2025 on the ground that, the reply given for his Form-1 dated 15.07.2025 is incomplete, evasive and fails to enclose crucial documents.

3. The response of the respondents were called for, vide notice dated 21.08.2025. The respondents have furnished their response vide letters dated 01.09.2025 and 30.08.2025 respectively(**Copy Enclosed**).

4. On perusal, the following facts are observed:

- a) The 1st respondent obtained information for Sl. Nos.3 & 4 of the petitioners Form-1 dated 15.07.2025 from the Planning Section and furnished the same to the petitioner vide letter dated 12.08.2025 after receiving the Xerox charges from him. Further the 1st respondent transferred the application of the appellant under Section 6(3) of the Act to the President-cum-Public Information Officer, 2ndrespondent-society for furnishing information for Sl.Nos.1,2,4, 5,6,7 & 8 directly to appellant on 21.07.2025.

- b) It is found that, the respondent-society has furnished the available information for Form-1 dated 15.07.2025 for Sl.No.1,2,4,5,6,7 & 8. vide their reply dated 4/08/2015. Further for the grounds/ Prayer made in the appeal by the Appellant , now the Respondent society has furnished the copies of circular No: 5/11/1/26/RCS/ Planning/M/2009/23. Dated 12.01.2012 & RCS/Planning/Directions/ 2019/22 dated 14.01.2020 and the information furnished therein in their response dated 30/08/2025 is found to be appropriate. Thus, it is observed that nothing survives in this appeal.
5. In view of the reasons stated above, the appeal lacks merits, and hence, Dismissed
6. If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
