ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 29.08.2024, under Section 6 of the Right to Information Act, 2005 (hereafter "the Act") to the 1st respondent and sought for certain information. The 1st respondent furnished information to the appellant for SI.Nos.1,2 & 4 vide letter dated 06.11.2024. Further the 1st respondent transferred the application under Section 6(3) of the Act to the President-cum-Public Information Officer, Kalapet Primary Agricultural Co-operative Credit Society Ltd., (2nd Respondent) on 04.09.2024 for directly furnishing the information to the appellant for SI.Nos.3,5,6 & 7. The 2nd respondent -society furnished reply to the appellant on 07.10.2024.

2. Aggrieved by the response of the respondents, the appellant filed this first appeal dated 21.10.2024 on the ground that, the reply received from the respondents for SI.Nos.1,3,4,5 & 6 of his Form-1 dated 29.08.2024 was not satisfactory.

3. The response of the respondents was called for, vide notice dated 28.10.2024. The 1st Respondent and the 2nd respondent-society have furnished their response vide letters dated 07.11.2024 and 21.11.2024 respectively (**Copy Enclosed**). On perusal, it is observed that the 1st respondent has furnished available information to the appellant for SI.Nos.1 & 4 of his Form-1 dated 29.08.2024. Further the 2nd respondent -society has also furnished available information to the appellant for SI.Nos.3,5 & 6 of his Form-1 dated 29.08.2024. Since the requisite information was furnished by the respondent, nothing survives in this appeal.

4. In view of the above, the first appeal is dismissed.

5. If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
