ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 20.09.2023, under Section 6 of the Right to Information Act, 2005, (**hereafter “the Act”**) to the respondent-society and sought for certain information. The respondent society furnished a reply on 16.10.2023.

2. Aggrieved by the response of the respondent- society, the appellant filed this first appeal dated 03.11.2023, on the ground that the reply of the respondent for Sl. nos.1,3,9,12,13 & 14 of his Form-1, is not correct and not satisfactory.

3. The response of the respondent was called for, vide notice dated 07.11.2023. The respondent society furnished their response vide letter dated 20.11.2023 (Copy Enclosed). The respondent-society has stated that the information already supplied by the society to the petitioner is correct and as per Law / provisions contemplated under the Right to Information Act, 2005 and requested the undersigned to dismiss the First Appeal as one not maintainable / benefit of merits apart from observation of the fact that the information sought does not fall under Section 2 (f) of the Right to Information Act, 2005 since the appellant has sought for disjointed information in an hazy manner.

4. On perusal, it is observed that, the reply / information furnished by the Respondent on 16.10.2023 as well as vide the response dated 07.11.2023 are upheld in respect of the Sl. Nos.3,9,12,13 & 14 except Sl. No.1. The appellant at Sl.No.1 sought the details of the employees who were regularised, promoted during the period from 2002 to 2022. The reply / response furnished and the reasons for non furnishing of the information in respect of Sl.no.1 by the Respondent are not found to be valid as per the Act. Therefore, the Respondent is directed to furnish the available information to the Appellant in respect of Sl.No.1 only, within 15 days from the date of receipt of this order, at free of cost.
