ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 14.08.2024, under Section 6 of the Right to Information Act, 2005, (hereafter “the Act”) to the respondent and sought for certain information. The Respondent furnished reply to the appellant vide letter dated 26.09.2024.

2. Aggrieved by the response of the respondent society, the appellant filed this first appeal dated 22.10.2024 on the ground that, the reply received for Sl.No.1 of his Form-1 was not satisfactory.

3. The response of the respondent was called for, vide notice dated 28.10.2024. The respondent has furnished his response vide letter dated 20.11.2024 (**Copy enclosed**). The respondent has stated that, the appellant’s request in Form-I dated 14.08.2024 seeking the action taken on the petition dated 24.04.2024 relating to the Kalapet Primary Agricultural Credit Society Ltd., P.No.96 (hereafter ‘society’) was forwarded to the society on 21.08.2024 for furnishing the information directly to the appellant. A copy of the reply furnished by the said society to the appellant on 16.09.2024 was received by the respondent. Further a copy of the application was also forwarded to the Credit Section on 21.08.2024 and the reply received was provided to the appellant on 26.09.2024 after the payment of prescribed Xerox fees by the appellant. On receipt of First Appeal Notice dated 28.10.2024, updated reply was received from the Credit Section on 18.11.2024 and the same is forwarded.

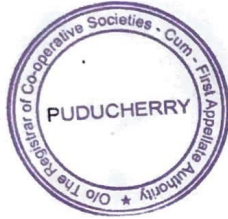
4. From the above it is observed that, the appellant has sought for the action taken report and final outcome of his representation dated 24.04.2024. In this regard the Respondent furnished the available information receipted from both the society as well as the Administrative Section. Further, the respondent furnished the same / updated available information. Hence, it is observed that, the respondent has provided the information available with him in respect of Sl.No.1 of appellant’s Form-I dated 14.08.2024.

5. In view of the above submissions, it is found that, the plea of the appellant is redressed. As nothing survives in this appeal, this first appeal is dismissed

6. If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
