ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 20.08.2025, under Section 6 of the Right to information Act, 2005,(hereafter “the Act”) to the respondent society and sought for certain information from the respondent society. The respondent society furnished reply to the appellant vide letter dated 15.09.2025.

2. Not satisfied with the response of the respondent society, the appellant filed this first appeal dated 26.09.2025 before the Public Information Officer of the respondent Society itself instead of preferring the said appeal before this Authority. Therefore the P.I.O. of the respondent society has forwarded this First Appeal application to this department vide letter dated 30.09.2025 which was received by this department on 30.09.2025 and by Co-operative Law Cell on 14.10.2025.

3. The response of the respondent-society was called for vide notice dated 15.10.2025. The respondent-society furnished its response vide letter dated 22.10.2025 (**Copy Enclosed**). On perusal, it is observed that, the appellant has stated that he had given three representations dated 10.11.2014, 29.07.2017 & 16.07.2025 regarding his promotion and sought for the action taken on these representations. For this, the respondent society has informed that, the first two representations dt. 10.11.2024 & 29.07.2017 are not found in the society. Further the respondent society has furnished reply for the third representation dt. 16.07.2025 of the appellant vide letter dated 23.08.2025. Thus the respondent society is found to have furnished the available information. The said reply is found to be valid and acceptable. Hence, it is observed that nothing survives in this appeal.
