ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 26.08.2024, under Section 6 of the Right to Information Act, 2005 (hereafter "the Act") to the 1st respondent and sought for certain information. The 1st respondent transferred the application under Section 6(3) of the Act to the President-cum-Public Information Officer, Kalapet Primary Agricultural Co-operative Credit Society Ltd., (2nd Respondent) on 02.09.2024 for directly furnishing the information to the appellant. The 2nd respondent -society furnished reply to the appellant on 30.09.2024.

2. Aggrieved by the response of the 2nd respondent -society, the appellant filed this first appeal dated 21.10.2024 on the ground that, the reply received was not satisfactory.

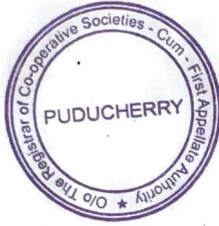
3. The response of the respondents was called for, vide notice dated 27.10.2024. The 1st Respondent and the 2nd respondent-society have furnished their response vide letters dated 05.11.2024 and 21.11.2024 respectively (Copy Enclosed). On perusal, it is observed that the 1st respondent has transferred the appellant's request in Form-1 dated 26.08.2024 to the 2nd respondent -society vide letter dated 02.09.2024 for furnishing the required information directly to the appellant and a copy of the reply furnished by the 2nd respondent -society to the appellant was received by the 1st respondent on 30.09.2024. The 2nd respondent -society has reiterated its already furnished to the appellant on 30.09.2024. At the outset, it is found that, the 2nd respondent -society has furnished the available information with them. Since the requisite information was furnished by the respondent, nothing survives in this appeal.

4. In view of the above, the first appeal is dismissed.

5. If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
