ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 22.11.2021, under Section 6 of the Right to Information Act, 2005,(hereafter “the Act”) to the respondent-society and sought for certain information from the respondent-society. The respondent – society furnished the information to the appellant on 11.12.2021.

2. Aggrieved by the respondent's response, the appellant filed this first appeal dated 17.12.2021 (received on 20.12.2021), on the ground that the reply of the respondent –society furnished information for SI.No.10,11,12,13,14 only which is not found satisfactory.

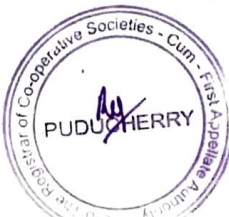
3. The response of the respondent was called for, vide notice dated 19th January 2022. The respondent-society furnished their response vide letter dated 15.02.2022 , under copy to the appellant (**Copy Enclosed**). On perusal, it is observed that the appellant made an application to the Deputy Registrar-cum- Public information Officer, Cooperative Department, Karaikal, on 22.11.2021, seeking information for SI.Nos. 1 to 14. Since, the SI.No. 10 to 14 pertains to the respondent-society, the said part only was transferred to them on 26.11.2021 by the D.R, Karaikal, for furnishing the information. The respondent-society furnished a reply on 11.12.2021. The appellant preferred this appeal since the information furnished was not satisfactory. Now, it is found that the respondent-society furnished a revised response to the undersigned, under copy to the appellant. Therefore, the plea of the appellant is found to be redressed and nothing remains unanswered.

4. In view of the above , as nothing survives in this appeal, this first appeal is dismissed.

5. If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
