ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 05.10.2024, under Section 6 of the Right to Information Act, 2005, (**hereafter “the Act”**) to the respondent-society and sought for certain information. The respondent society furnished a reply on 05.11.2024.

2) Aggrieved by the response of the respondent, the appellant filed this first appeal dated 16.11.2024 (received by this office on 18.11.2024), on the ground that the respondent has not supplied him the required information sought for.

3) The response of the respondent was called for, vide notice dated 22.10.2024. The respondent furnished his response, vide letter dated 30.11.2024 (**Copy Enclosed**). On perusal of the records available, it is found that –

a) In respect of Sl. No. 1, the appellant has sought for the production details of the mill for the period from 01.03.2023 to 30.09.2024, countwise and monthwise for which the respondent did not provided the information and informed the appellant to obtain those details from the Notice Board of the mill, which is found to be improper. Hence, the respondent is directed^{to} furnish the available information for Sl. No.1 of Form-1 dated 05.10.2024 to the applicant, on free of cost, within 15 days from the date of receipt of this order.

b) In respect of Sl.Nos.2 & 3, regarding the details about the monthwise production income of the mill and the monthwise as well as the total amount received from Sri Murugar Mills respectively, the respondent's reply that the information could be provided only after the finalization of the accounts of the mill is not found to be valid. Hence, the respondent is directed to furnish the available information for Sl.Nos.2 & 3 of Form-1 dated 05.10.2024 to the applicant, on free of cost, within 15 days from the date of receipt of this order.

- 4) With the above directions, this appeal is disposed of.
- 5) If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
