ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 06.10.2025, under Section 6 of the Right to Information Act, 2005, (hereafter "the Act") to the 1st respondent and sought for certain information pertaining to the Kalapet Primary Agricultural Co-operative Credit Society Ltd., (2nd respondent society). The 1st respondent transferred the application of the appellant under Section 6(3) of the Act to the President-cum-Public Information Officer/ 2nd respondent-society for furnishing information directly to appellant on 14.10.2025. The 2nd respondent-society furnished information to the appellant on 03.11.2025.

2. Not satisfied with the response of the 2nd respondent-society for his Form-I dated 06.10.2025, the appellant filed this first appeal dated 01.12.2025 (received in this office on 09.12.2025) on the ground that, the reply received was not satisfactory.

3. The response of the respondents were called for, vide notice dated 09.12.2025. The 1st respondent has furnished his response vide letter dated 05.01.2026 (**Copy Enclosed**). But no reply is received from the 2nd respondent-society till date.

4. On perusal, of the response received from the 1st respondent, it is found that, 1st respondent has now furnished the information obtained from the Administrative Section vide letter dt. 31.12.2025. On the perusal of the reply furnished by the 1st respondent, the following are observed.

a] **For Sl. No.1** of the Form -1 dated 06.10.2025 of the appellant, the appellant has requested the details and outcome of his representation dt. 10.03.2025. In this regard, the President of the 2nd respondent-society being the appointing / disciplinary authority of the appellant is instructed to consider the representation dt. 10.03.2025 and dispose within a period of 15 days from the date of receipt of this order.

b] **For Sl. No.2** of the Form -1 dated 06.10.2025 of the appellant, regarding the inspection of the records, the PIO/1st respondent shall co-ordinate with the Administrative section and may permit the appellant to inspect the records by the appellant after prior intimation.

c] **For Sl. No.3** of the Form -1 dated 06.10.2025 of the appellant, calling for the attested copy of the report; it is instructed that the attested report may be furnished by the 2nd respondent-society to the appellant after the receipt of the report.

d] **For Sl. No.4** of the Form -1 dated 06.10.2025 of the appellant, calling for the proof of dispatch, the reply / information given by the 1st respondent is found to be proper.

e] **For Sl. No.5** of the Form -1 dated 06.10.2025 of the appellant, the information sought by the appellant, if any, may be furnished by the PIO/1st respondent within a period of 15 days from the date of receipt of this order, at free of cost.

5. Further, both the respondents are directed to dispose the application made under the said Act meticulously, in letter and spirit, by providing the available information at the initial stage itself.

6. With the above directions, this appeal is disposed of.

7. If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
