ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 12.12.2024, under Section 6 of the Right to Information Act, 2005, (hereafter “the Act”) to the respondent-society and sought for certain information. The respondent society furnished a reply on 10.01.2024.

2) Aggrieved by the response of the respondent-society, the appellant filed this first appeal dated 05.02.2024, on the ground that the information furnished by the respondent-society is not correct and unsatisfactory except for Item No.9.

3) The respondent-society furnished its response, vide letter dated 23.02.2024. On perusal of the records available, it is found that -

- a)** The information sought for under **Item Nos. 1 & 2** are not clear. The appellant should have written his application without any ambiguity.
- b)** In respect of **Item No.4**, the appellant didn't furnish any documentary evidence to prove his allegation that 15 employees don't work in the office even though they sign in the attendance register.
- c)** In respect of **Item No.5**, the appellant sought for details of nature of work, for which, the respondent-society furnished that, information is not available. The appellant cannot seek information which are not available.
- d)** In respect of **Item No.8**, the appellant didn't furnish any documentary evidence to prove his claim that employees have been signing for more than 10 years.

4) In respect of **Item No.3**, the respondent-society shall furnish the remaining information, such as, educational qualification and experience certificate to the appellant, if such information is available with them. In respect of **Item No.6**, the respondent-society shall furnish the details of twice-promotion, to the appellant, if such information is available with them. In respect of **Item No.7**, the respondent-society shall furnish copy of transfer order(s), if any, to the appellant. ***The respondent-society shall furnish the information for Item Nos. 3, 6 & 7 to the applicant, on free of cost, within 10 days from the date of receipt of this order, and in the event of non-availability of information in the society, the respondent-society shall inform this to the appellant within ten days under intimation to the undersigned.***

5. With the above directions, this appeal is disposed of.

6. If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
