ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 27.12.2024, under Section 6 of the Right to Information Act, 2005, (hereafter “the Act”) to the respondent and sought for certain information. The respondent-society furnished a reply on 30.01.2024.

2. Aggrieved by the response of the respondent, the appellant filed this first appeal dated 08.01.2024 on the ground that, the reply furnished is incomplete.

3. The response of the respondent-society was called for, vide notice dated 15.02.2024. The respondent furnished their response vide letter dated 26.02.2024 (Copy Enclosed). On perusal of the records available, it is found that –

a) The information sought by the appellant for Item Nos. 1 & 2 is found to be furnished by the respondent- society.

b) In respect of Item Nos.2 (1), 2(2), 2(3), 2(4), regarding the details about the employees working in the branch office of the society, the respondent-society’s reply that, the information could not be provided as per Sec.8(1)j of the Right to Information Act, 2005 is not found to be acceptable. Hence, the respondent-society shall furnish the information for Item Nos.2 (1), 2(2), 2(3), 2(4), to the applicant, on free of cost, within 10 days from the date of receipt of this order.

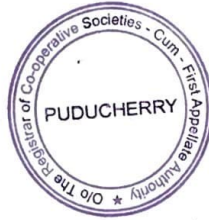
c) In respect of Item Nos.2 (5) & 2(6), the information sought by the appellant regarding the employees is found to be a general one. Therefore, the appellant is directed to visit the respondent society during the office hours in respect of the information sought at Sl.Nos.2(5) & 2(6) made in his application dated 27.12.2023 within 15 days from the date of receipt of this order and in turn the respondent society is directed to furnish the available information to the appellant, within 15 days from the date of such visit made by the appellant, at free of cost.

4. With the above directions, this appeal is disposed of.

5. If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
