ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 13.12.24, under Section 6 of the Right to Information Act, 2005, (hereafter "the Act") to the 1st respondent and sought for certain information. The Respondent furnished reply to the appellant vide letter dated 22.08.2024. The 1st respondent transferred the application under Section 6(3) of the Act to the President-cum-PIO, Sanniyasikuppam Primary Agricultural Co-operative Credit Society Ltd., No.P.61 (2nd Respondent) on 16.12.2024 for directly furnishing the information to the appellant. The 2nd respondent-society furnished a reply to the appellant on 08.01.2024.

2. Aggrieved by the response of the 2nd respondent-society, the appellant filed this first appeal dated 22.01.2025 on the ground that, the reply received was not satisfactory.

3. The response of the respondents were called for, vide notice dated 29.01.2025. The 1st respondent and the 2nd respondent society have furnished their response vide letters dated 04.02.2025 and 17.02.2025 respectively (**Copies Enclosed**). On perusal, it is observed that the 1st respondent has transferred the appellant's request in form-1 dated 22.08.2024 to the 2nd respondent society vide letter dated 16.12.2024 for furnishing the required information directly to the appellant and a copy of the reply furnished by the 2nd respondent society to the appellant on 21.01.2025 was received by the 1st respondent.

4. The 2nd respondent society has reiterated its reply already furnished to the appellant on 30.09.2024. At the outset, it is found that, the 2nd respondent society has furnished the available information with them for **Sl.No.5** (Bye law copy of the society) & **Sl.No.8** (Passbook copy from 01.02.2018 to 10.12.2024).

5. Further the 2nd respondent society has furnished information **partly** for **SI. No.1**(Agricultural loan .ie KCC loan given from 2018 to 2024), **SI.No.3** (No Government Fund received for the issue of Agricultural and Jewel loans to members), **SI.No.4** (Tractor hire charge details), **SI.No.6** (Date of joining and salary / wages details of staffs of the society) and requested the petitioner to visit the society and inspect the remaining information. Further for **SI.No.2** (Jewel loans issued from 01.12.2018 to 10.12.2024, signature obtained in the register and receipts) & **SI.No.7** (Copy of the Resolutions passed in the society from 01.02.2018 to 10.12.2024 signed by the 9 directors) the respondent society has requested the petitioner to visit the society and obtain the remaining information.

6. On perusal, it is ordered that, the 2nd respondent society is directed to furnish the remaining information in respect of **SI.No.1** (Jewel loans & receipt details), **SI.No.2** (Jewel loans issued from 01.12.2018 to 10.12.2024, signature obtained in the register and receipt details), **SI.No.3** (Transactions of CCL Account for the fund received from the PSCB for issue of Agricultural and Jewel loans to members from 01.12.2018 to 10.12.2024), **SI.No.4** (Details of Tractor beneficiaries and receipts), **SI.No.6** (Copy of the vouchers/ receipts pertaining to the salary / wages of the staffs of the society) and **SI.No.7** (Copy of the Resolutions passed in the society from 01.02.2018 to 10.12.2024 signed by the 9 directors) of the petitioner's Form-I dated 13.12.2024 within 15 days of receipt of this order, free of cost.

6. In view of the above, this first appeal is disposed of.

7. If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
