ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 19.12.2025, under Section 6 of the Right to Information Act, 2005, (hereafter "the Act") to the 1st respondent and sought for certain information pertaining to the Pondicherry Central Co-operative Processing Supply and Marketing Society Ltd., (2nd respondent society). The 1st respondent transferred the application of the appellant under Section 6(3) of the Act to the President-cum-Public Information Officer/ 2nd respondent-society for furnishing information directly to appellant on 29.12.2025. The 2nd respondent-society furnished information to the appellant on 29.12.2025.

2. Aggrieved with the response of the 2nd respondent-society for his Form-I dated 19.12.2025, the appellant filed this first appeal dated 05.01.2026 (received in this office on 19.01.2026) on the ground that, the reply received was not satisfactory.

3. The response of the respondents were called for, vide notice dated 21.01.2026. The respondents have furnished their response vide letters dated 29.01.2026 and 04.02.2026 **(Copies Enclosed).**

4. On perusal of the response received from the 2nd respondent-society, the following are observed.

a] **For Sl. No.1** and for **Sl.No.3** of the Form -1 dated 19.12.2025 of the appellant, seeking for information relating to the tender for the purchase of items for the Anganwadi, the reply / information given by the 2nd respondent- society is found to be meeting the information sought.

b] **For Sl. No.2** of the Form -1 dated 19.12.2025 of the appellant, seeking information regarding the details of payment made to the supplier of the Anganwadi for the past one year, the respondent-society in their response stated that, the information sought is not clear, is not found to be proper. Hence, the undersigned directs that, the available information may be furnished to the appellant by the PIO/2nd respondent-society within a period of 15 days from the date of receipt of this order, at free of cost.

c) **For Sl. No.4** of the Form -1 dated 19.12.2025 of the appellant, seeking information regarding orders given without tender, the respondent-society's reply that, the information sought is not clear, is not found to be proper. Hence, the undersigned directs that, the available information may be furnished to the appellant by the PIO/2nd respondent-society within a period of 15 days from the date of receipt of this order, at free of cost.

5. With the above directions, this appeal is disposed of.

6. If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
