ORDER

(Issued under Section 19 of the Right to Information Act, 2005)



The appellant submitted an application dated 29.12.2023, under Section 6 of the Right to Information Act, 2005, (hereafter “the Act”) to the respondent and sought for certain information. The respondent-society furnished a reply which was received by the appellant on 02.02.2024.

2. Aggrieved by the response of the respondent, the appellant filed this first appeal dated 19.02.2024 on the ground that, correct information needs to be given.
3. The response of the respondent-society was called for, vide notice dated 22.02.2024. The respondent-society furnished its response, vide letter dated 20.03.2024 (**Copy Enclosed**). On perusal of the records available, it is found that –
 - a) The information sought for under **Item Nos. 1,2,3,4,7 & 8** are now furnished by the respondent- society and it is found to met out the plea of the appellant.
 - b) In respect of **Item No.5**, the appellant has called for the details of the Earned leave encashment payable to Thiru.P.S.Veerappan, S/o.Subramanian, but the society has replied that Earned leave encashment cannot be given since the society is running under loss. The said reply is not found to be acceptable. Hence, the society is instructed to furnish the details of Earned leave accrued and the amount payable to Thiru.P.S.Veerappan, S/o.Subramanian, retired Secretary of the society as on the date of his retirement.
 - c) In respect of **Item No.6**, the appellant has called for the details of the LIC Group Insurance received by the society after the year 2019 along with the details of the staff for whom the amount was received and the details of amount disbursed to them. The reply furnished by the society for this is not clear. Hence, the society is instructed to furnish the said details of LIC Group Insurance receipted by the society alongwith the staff name list as sought by the appellant.

Therefore, the respondent-society shall furnish the information for Item Nos. 5 & 6 to the applicant, on free of cost, within 15 days from the date of receipt of this order.

5. With the above directions, this appeal is disposed of.

6. If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
