ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 08.01.2024, under Section 6 of the Right to Information Act, 2005, (hereafter “the Act”) to the respondent and sought for certain information. The respondent society furnished a reply on 29.01.2024 which is said to have not received by the appellant.

2. Aggrieved by the non response of the respondent, the appellant filed this first appeal dated 08.01.2024.

3. The response of the respondent was called for, vide notice dated 22.02.2024. The respondent furnished their response vide letter dated 26.02.2024 (**Copy Enclosed**). On perusal, it is observed that, the appellant application dated 08.01.2024 was forwarded to the Planning Section of this department on 11.01.2024 and the information consisting of 9 pages were received on 23.01.2024. In this regard, the appellant was informed to remit Rs.18/- to this office vide letter dated 29.01.2024. The said intimation letter was received by the appellant on 01.02.2024 (**Acknowledgement Copy Enclosed**). It is found that, till date, the appellant did not remit the requisite amount for furnishing the Xerox copies of the information sought. But, the appellant has preferred this appeal on the ground that, no reply was received from the respondent which is not true.

4. Therefore, the appellant is informed to remit Rs.18/- in the office (Co-operative Department) and produce the copy of the receipt to the respondent. The respondent is directed to furnish the Xerox copies of the information to the appellant on receipt of the remittance of amount in the department.
