ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 16.02.2024, under Section 6 of the Right to Information Act, 2005, (**hereafter “the Act”**) to the respondent and sought for certain information. The respondent society furnished a reply on 07.03.2024.

2. Aggrieved by the response of the respondent, the appellant filed this first appeal dated 18.03.2024, on the ground that the respondent has intentionally suppressed the facts and not supplied the information sought.

3. The response of the respondent was called for, vide notice dated 21.03.2024. The respondent has furnished his response vide letter dated 08.04.2024 (**Copy Enclosed**). On perusal, it is found that, the respondent society for Sl. No.1 stated that “ no information is available regarding the cadre wise vacancy as on 10.10.2014 as sought by the appellant in the records of the society” and for Sl. No.2 stated that “the society did not maintained such records. Hence, the information sought by the appellant could not be furnished”. From the above it is found that, the respondent society has stated about the non availability of the information sought and the non maintenance of the records for furnishing the information sought by the appellant. From the above, it is evident that, the respondent society has furnished the information available in the society. Therefore, the reply furnished by the respondent-society is found to be appropriate.

4. In view of the above, as nothing survives in this appeal, this first appeal is dismissed.

5. If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
