ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 24.12.2025, under Section 6 of the Right to Information Act, 2005, (**hereafter “the Act”**) to the 1st respondent and sought for certain information pertaining to the Indian Coffee Workers Co-op. Society Ltd., P.67 (**2nd respondent-society**). The 1st respondent forwarded the application to the 2nd respondent-society on 05.01.2026 for furnishing the information sought by the applicant. The reply 2nd respondent-society furnished response to the appellant vide letter dated 27.01.2026.

2. Not satisfied with the response of the 2nd respondent-society for his Form-I dated 24.12.2025, the appellant filed this first appeal dated 19.02.2026 (received in this office on 24.02.2026) on the ground that, the reply received was incomplete, misleading, unsatisfactory and without Public Information Officer's signature and seal.

3. The parties are called up for a personal hearing on 30.03.2026. Except the 2nd respondent-society other parties are present. During the hearing, the petitioner stated that he wants the information about the Provident Fund details, as sought in the Sl.No.12 of his RTI application dated 24.12.2025. The petitioner further stated that, he is not aggrieved except for Sl.No.12 of his application. In view of the above, the undersigned hereby orders that the 2nd respondent-society shall furnish the available information as sought at Sl.No.12 of his application, with proper attestation of the Public Information Officer, at free of cost within 15 days from the date of receipt of this order.
