ORDER

(Issued under Section 19 of the Right to Information Act,2005)

The appellant submitted an application dated 04.02.2025, under Section 6 of the Right to Information Act, 2005, (hereafter “the Act”) to the respondent-society and sought for certain information. But, the respondent society did not furnish the information sought by the appellant.

2. Aggrieved by the non-response of the respondent- society, the appellant filed this first appeal dated 05.03.2025 which was received by this office on 18.03.2025.

3. The response of the respondent society was called for, vide notice dated 18.03.2025. The respondent has furnished his response vide letter dated 27.03.2025 received in this office on 07.04.2025 (**Copy Enclosed**). On perusal, the following are observed and ordered:

- a] The respondent society has furnished the available information for sl.nos.16,17,18 & 19 of the appellants Form-1 dt. 04.02.2025.
- b)
 - (i) In respect of Sl.No.2,3,4,5,6, 8,9,10 & 11 of the appellants Form-1 dt. 04.02.2025, the appellants have sought information / copy of the information, but the reply furnished for these sl.nos by the respondent society is not proper. For many information sought, the reply is simply given as 'எழுவில்லை'. The said reply is not valid.
 - (ii) In this regard, the respondent-society is ordered to furnish proper reply / available information / copy of the information for Sl.Nos.2,3,4,5,6,7,8,9,10 &11 as sought for in the appellants Form-1 dated 04.02.2025 within a period of 15 days from the date of receipt of this order, free of cost.
- c] In respect of Sl.Nos.1, 7,12,13,14 & 15 of the appellants Form-1 dt. 04.02.2025, The information sought by the appellant are not clear. The appellant should have sought information in his application without any ambiguity. Therefore, the respondent-society is unable to understand the information sought by the appellant and thus the appropriate information could not be provided by the Respondent-society.

In view of the above, this first appeal is disposed of.

If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
