ORDER

(Issued under Section 19 of the Right to Information Act,2005)

The appellant submitted an application dated 27-11-2020, under Section 6 of the Right to Information Act, 2005, (hereafter "the Act") to the respondent and sought for certain information. The respondent furnished information on 22-12-2020 to the appellant.

2. Aggrieved by the respondent's response, stating that the required information was not furnished, the appellant filed this first appeal dated 07-01-2021.

3. The response of the respondent was called for. The respondent furnished his response vide letter dated 15-02-2021 (**Copy forwarded to the Appellant**). On perusal of the file, it is ascertained that the respondent furnished the available information on 22-12-2020, with a reservation that the letter dated 01-07-2019 tendered by the SPINCO Labour Union is not available in the Mills. In the response dated 16-02-2021, the respondent reiterated that the information sought by the appellant were furnished as per the records available in the Mills. The respondent furnished additional information in respect of the SPINCO Labour Union letter dt. 01-07-2019, which was received by the respondent on 15-02-2021.

4. Hence, it is observed that the respondent furnished the available information to the appellant well within the statutory time limit and on receipt of the Union letter dt. 01-07-2019, the additional available information is also furnished to the appellant. It is also found that, the appellant preferred this appeal with an evasive say that "the required information was not furnished", without any substantial grounds.

5. In view of the above, nothing survives in this appeal, and hence, this first appeal is dismissed for lack of merits.

6. If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
