ORDER

(Issued under Section 19 of the Right to Information Act, 2005)

The appellant submitted an application dated 02-03-2021, under Section 6 of the Right to Information Act, 2005, (**hereafter "the Act"**) to the respondent and sought for certain information. The respondent furnished the information to the appellant on 30-03-2021.

2. Aggrieved by the respondent's response in respect of the Sl.No.1, 3,8,9,12, the appellant filed this first appeal dated 08-04-2021.

3. The response of the respondent was called for. The respondent furnished their response, vide letter dated 22.04.2021, (**Copy forwarded to the Appellant**) stating that already the available information was furnished in respect of Sl.No.1,3,8,9,12 on 30-03-2021 and reiterated their stand that copies sought for in Sl.No.1,3,8,9 could not be furnished as it relates to personal information and as much as it is exempted for its disclosure under Sec (8) (1)(g) and (j) of the Act. However, it is also stated that the appellant may visit the society for perusal of the information sought at Sl.no.1 and 3. In respect of information sought at Sl.No.12, it is stated that no resolution was passed.

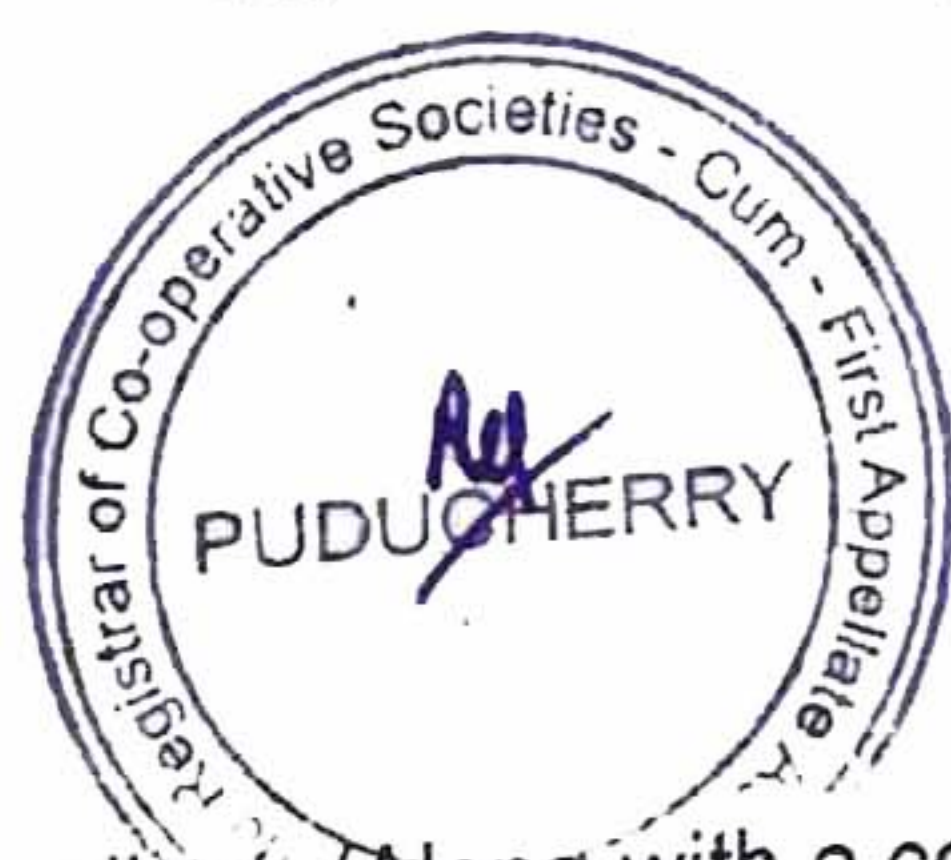
4. On perusal, it is observed that the respondent furnished the available information to the appellant for the information sought at Sl.No.1 to 12. The plea made by the respondent that copies sought for in Sl.No.1,3,8,9 could not be furnished as it relates to personal information and as much as it is exempted for its disclosure under Sec (8) (1)(g) and (j) of the Act is upheld. It is imperative to note that, the respondent stated in their reply dt. 30-03-2021 as well as in their response dt. 22.04.2021, the appellant may visit the society for perusal of the information sought at Sl.no.1 and 3. In respect of the Sl.No.12, it is observed that the available information is furnished. Accordingly, nothing needs to be redressed.

5. In view of the above, this appeal is dismissed, for lack of merits.

6. If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
