**ORDER**

***(Issued under Section 19 of the Right to Information Act,2005)***

The appellant submitted an application dated 29-07-2020, under Section 6 of the Right to Information Act, 2005, (hereafter "the Act") to the 1<sup>st</sup> respondent (received on 30-07-2020) and sought for certain information. The 1<sup>st</sup> respondent forwarded the said application on 13-08-2020 to the 2<sup>nd</sup> respondent for furnishing the information sought at Sl.No. 1 to 5 & 7 to 10 directly to the appellant. The 1<sup>st</sup> respondent furnished the information for Sl. No.6 to the appellant on 20-08-2020.The 2<sup>nd</sup> respondent furnished the rest of the information to the appellant on 09-09-2020.

2. Aggrieved by the respondents' response, the appellant filed this first appeal dated 23-09-2020 (Received on 25-09-2020).

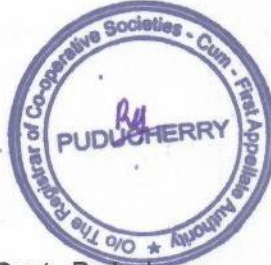
3. The response of the respondents were called for. The 1<sup>st</sup> respondent furnished their response, vide letter dt. 09-10-2020 ( **Annexure-A-Copy forwarded to the Appellant**) and the 2<sup>nd</sup> respondent furnished their response, vide letter dt. 08-10-2020 ( **Annexure-B-Copy forwarded to the Appellant**). On perusal of the 1<sup>st</sup> respondent's response, it is observed that the available information was furnished to the appellant even though the appellant sought the said information " in question form", which is need not to be replied. Further, on perusal of the 2<sup>nd</sup> respondent response, it is observed that the requisite information was furnished to the appellant except for **Sl.No.10 of his application dt.29-07-2020.**

4. In view of the above, the 2<sup>nd</sup> respondent-society is ordered to furnish the requisite and relevant information, if any, to the appellant for **Sl.No.10 of his application dt.29-07-2020, within 15 days, at free of cost**, from the date of receipt of this order, under copy to this authority, without fail. Accordingly, this first appeal is disposed off.

5. If aggrieved by this decision, a 2<sup>nd</sup> Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2<sup>nd</sup> Appellate Authority, whose address is given below:
