ORDER

The appellant submitted an application dated **02.09.2020**, under the Right to Information Act, 2005, to the respondent and sought for certain information. The respondent didn't respond, and hence, the appellant filed this 1st appeal dated **06.10.2020**. On perusal, it is observed that, most of the items in the appellant's application dated 02.09.2020 seem to be vague. However, the respondent's response was called for and the respondent filed his response dated **26.10.2020** for this 1st appeal. The respondent's contentions don't score any merits. In the personal hearing held on **09.11.2020**, respondent's representative agreed to provide available information to the appellant.

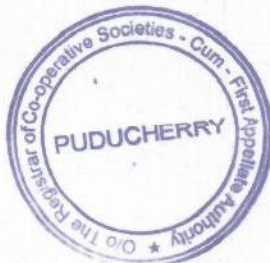
2) As agreed in the said personal hearing, the respondent shall furnish either the available information, if any, on free of cost, or a reply to the appellant, as the case may be, within ten (10) days from the date of receipt of this order. The appellant is instructed to specify the correct name of the cooperative society, period for which information is sought for, etc., while submitting applications under the said Act.

3) With the above instructions, **this first appeal is disposed of.**

4) If aggrieved by this decision, a **2nd Appeal** may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
